**AN ORDINANCE OF THE TOWNSHIP OF BERKELEY, COUNTY OF OCEAN,
STATE OF NEW JERSEY, AMENDING THE TOWNSHIP CODE, SO AS TO AMEND
CHAPTER VII, ENTITLED "TRAFFIC"**

January 4, 2017

BE IT ORDAINED by the Mayor and Township Council of the Township of Berkeley, County of Ocean, and State of New Jersey, as follows:

SECTION 1. Chapter VII of the Township Code of the Township of Berkeley, entitled "Traffic," is hereby amended so as to amend §7-16, entitled "Residential Permit Parking," which shall now read in its entirety as follows:

§7-16 RESIDENTIAL PERMIT PARKING.

No person shall park a vehicle on streets or parts of streets as described within the following sections unless an appropriate and current parking permit as issued by the Township of Berkeley is displayed on said vehicle for those streets or parts of streets as described or listed within the following sections.

Astor Place	Both	Monday through Friday 7:00 a.m. to 3:00 p.m.	Between Grand Central Parkway (CR#91) and end of roadway
Dorsey Lane	Both	Monday through Friday 7:00 a.m. to 3:00 p.m.	Between Forest Hills Parkway (CR#55) and Hancock Avenue
Lester Lane	West	Monday through Friday/ 7:00 a.m. to 3:00 p.m.	Between Forest Hills Parkway (CR#55) and Vanderbilt Avenue
Moorage Avenue	South	7/24	Between Red Bank Avenue and Veeder Lane
Partridge Lane	East	April 15 to October 1	Between Mallard Road and Loon Place
Vanderbilt Avenue	Both	Monday through Friday/ 7:00 a.m. to 3:00 p.m.	Between Grand Central Parkway (CR#91) and East End Avenue
3 rd Avenue	South	24 hours / 7 days a week	From 6 th Street west to 7 th Street

Residential Parking Permits shall be available to only Township Residents, Tenants, business owners, and homeowners for the above listed locations. There shall be a limit of Four (4) permits per residence. Parking permit applications are available at the Police Department and will be issued upon proper proof of residency or ownership, such as a driver's license, vehicle registration, or other documentation found acceptable by the Police Department.


SECTION 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 3. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 4. This ordinance shall take effect after second reading and publication as required by law.
