

ORDINANCE NO. 2024 -54-OA

AN ORDINANCE OF THE TOWNSHIP OF BERKELEY, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING VARIOUS SECTIONS OF SECTION 26 ENTITLED "USE OF PUBLIC RESORTS" (DEPOSITS FOR FACILITIES; SENIOR RECREATION TRIP FEES)

October 1, 2024

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Township Council of the Township of Berkeley, County of Ocean, and State of New Jersey, as follows:

SECTION 1. Section 26-1.8 of the Township Code, entitled "Picnic and Beach Fees", from Chapter 26 entitled "Use of Public Resorts" of the Township Code is hereby revised to add subsection a.6, to read as follows:

§ 26-1.8. Picnic and Beach Fees.

a. Policies and Fees. It is recognized by the Township that policies related to the use of Township fields, buildings and other facilities as well as addressing the fees set forth therein are necessary. These policies and fees may be adopted and amended by resolution of the Township Council. Fees set by such resolution(s) shall be within the following ranges:

6. Deposits ranging from \$100-\$200 shall be permitted to be charged and kept in the event of damage to facilities.

SECTION 2. Section 26-1.13 of the Township Code, entitled "Senior Program Registration", from Chapter 26 entitled "Use of Public Resorts" of the Township Code is hereby revised, to read as follows:

§26-1.13 Senior Program Registration.

There shall be a fee of fifteen (\$15.00) dollars per year per individual for participation in the Berkeley Township Senior Recreation Program.

SECTION 3. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 4. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 5. This ordinance shall take effect after second reading and publication as required by law.


