

ORDINANCE NO. 2025 -48-OAB

**AN ORDINANCE OF THE TOWNSHIP OF BERKELEY, COUNTY OF OCEAN,  
STATE OF NEW JERSEY, AUTHORIZING THE VACATION OF PORTIONS OF  
ANDREW AVENUE (BETWEEN ELIZABETH AVENUE AND VETERANS  
BOULEVARD) ABUTTING BLOCK 540, LOTS 20.01 & BLOCK 546 LOT 26.01**

**WHEREAS**, there exists a right-of-way on Andrew Avenue(near the northerly line of Elizabeth Avenue), Block 540, Lot 20.01 and Block 546, Lot 26.01 on the Berkeley Township Tax Map, County of Ocean, State of New Jersey; and

**WHEREAS**, the Township Engineer has reviewed the request to vacate portions of Andrew Avenue(between Elizabeth Avenue and Veterans Boulevard), described in Schedule A, provided by the property owner of adjacent property, and approves of same; and

**WHEREAS**, N.J.S.A. 40A:12-13(b)(4) authorizes the Berkeley Township Council to extinguish and vacate said portions of the street provided that said action is authorized by Ordinance.

**NOW, THEREFORE, BE IT ORDAINED** by the Township Council of the Township of Berkeley, County of Ocean, State of New Jersey, as follows:

**SECTION 1.** There is hereby vacated all of the right, title, and interest of the public for all public usages and purposes in and to those portions of Andrew Avenue(near the northerly line of Elizabeth Avenue) abutting Block 540, Lots 20.01 & Block 546, Lot 26.01, as is set forth on Schedule A, attached hereto and made a part hereof. However, the Township does hereby expressly reserve and except from the vacation all rights and privileges now possessed by public utilities, as defined in R.S. 48:2-13, and by any cable television company, as defined in the "Cable Television Act," P.L. 1972, c. 186, (C. 48:5A-1, *et seq.*), to maintain, repair and replace their existing facilities in, adjacent to, over or under the street, highway, lane, alley, square, place or park, or any part thereof, being vacated by the provisions of this ordinance.

**SECTION 2.** At least one (1) week prior to the time fixed for further consideration for final passage of this ordinance, a copy hereof, together with a notice stating the introduction of the ordinance on first reading and the time and place when and where the ordinance will be considered for final passage, shall be mailed to every person whose lands may be affected by the adoption of the ordinance.


**SECTION 3.** This ordinance shall be published at least once in an official newspaper of the Township of Berkeley at least ten (10) days prior to the time fixed for consideration of the final passage of the ordinance.

**SECTION 4.** The Township Clerk, if this ordinance is adopted on final reading, shall submit a certified copy of this ordinance, together with proof of publication, to the Ocean County Clerk's Office for recording in the Book of Vacations.

**SECTION 5.** This ordinance shall take effect after second reading and publication as required by law.

**SECTION 6.** A copy of Schedule A as referenced herein shall be kept on file and made available for public inspection in the Township Clerk's Office during normal business hours.

**SECTION 7.** A condition of the vacation of the portion of Andrew Avenue(between Elizabeth Avenue and Veterans Boulevard) is that this street must be consolidated with the property owned by the owners of Block 546, Lot 26.01.




