

ORDINANCE NO. 2026-01-OA8

**AN ORDINANCE OF THE TOWNSHIP OF BERKELEY, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING THE TOWNSHIP CODE, SO AS TO AMEND CHAPTER VII, ENTITLED "TRAFFIC" §7-10.1, ENTITLED "STOPPING OR STANDING PROHIBITED" (KORMAN ROAD)**

*January 1, 2026*

**BE IT ORDAINED** by the Mayor and Township Council of the Township of Berkeley, County of Ocean, and State of New Jersey, as follows:

**SECTION 1.** Chapter VII of the Township Code of the Township of Berkeley, entitled "Traffic," is hereby amended so as to amend §7-10.1, entitled "Stopping or Standing Prohibited," to include the roadway listed below which shall read as follows:

**§7-10.1 STOPPING OR STANDING PROHIBITED.**

No person shall stop or stand a vehicle upon any of the streets or parts of the streets described, except where other parking regulations have been provided for.

**SECTION 2.** All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

**SECTION 3.** If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.


**SECTION 4.** This ordinance shall take effect after second reading and publication as required by law.
