

ORDINANCE # 24-08-OA 6

AN ORDINANCE OF THE TOWNSHIP OF BERKELEY, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING CHAPTER XX, ENTITLED "SOLID WASTE MANAGEMENT" SO AS TO AMEND VARIOUS SECTIONS



SECTION 1. Chapter 20 of the Township Code of the Township of Berkeley, entitled "Solid Waste Management," is hereby amended and supplemented so as to amend §20-1.2, entitled "Containers; Pickup Schedule", which shall now read as follows:

§20-1.2 Containers; Pickup Schedule


- a. Containers for garbage shall be made of galvanized iron or plastic. They shall be equipped with a proper fitting cover and be watertight. Containers shall have a capacity not in excess of 32 gallons and, when filled, shall not exceed 50 pounds in weight. Drums of any type shall not be used for garbage, even if fitted with lids and handles.
- b. Solid waste collection shall be limited to curbside collection along public streets or roads that have been dedicated to and accepted by the Township. The Township Sanitation Department shall not enter upon private property to remove solid waste from dumpsters or other containers.
- c. The Mayor is hereby authorized and directed to establish and promulgate reasonable regulations detailing the manner, days and times for the collection of solid waste as are required to implement this section.
- d. An automated refuse container can be obtained from the Department of Public Works. A second automated refuse container may be purchased at the following rate: \$65 for a large container and \$55 for a small container.

e. Extra garbage collection can be scheduled with the Department of Public Works for a fee of \$250 per pickup.

SECTION 2. Chapter 20 of the Township Code of the Township of Berkeley, entitled "Solid Waste Management," is hereby amended and supplemented so as to amend §20-1.12, entitled "Cleanout/Moveout Fees", which shall now read as follows:

§20-1.12 Cleanout/Moveout Fees

No person shall place at the curb or anywhere else the contents of a residential dwelling for collection at the time of an entire cleanout of the dwelling unless and until a fee of \$250 is paid to the Township of Berkeley and arrangements are made with the Department of Public Works for such collection. The \$250 fee is limited to a collection that would fill a 4x4x8 container. Amounts in excess of that limitation will necessitate additional \$250 fee(s) as applicable.

SECTION 2. Chapter 20 of the Township Code of the Township of Berkeley, entitled "Solid Waste Management," is hereby amended and supplemented so as to amend §20-1.13, entitled "Reserved", which shall now read as follows:

§20-1.13 Construction Debris

The disposal of construction debris for pickup by the Township shall be prohibited. Violators shall be subject to violations and penalties as contained in this Chapter.

SECTION 3. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 4. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.
