

ORDINANCE NO. 24-01-OA *B*

**AN ORDINANCE OF THE TOWNSHIP OF BERKELEY, COUNTY OF OCEAN,
STATE OF NEW JERSEY AUTHORIZING THE DONATION OF BLOCK
837.01, LOTS 1.01, 1.02 & 1.06, TO THE COUNTY OF OCEAN, IN
ACCORDANCE WITH N.J.S.A. 40A:12-13**

WHEREAS, the Township of Berkeley owns Block 837.01, Lots 1.01, 1.02 & 1.06, which are located in the Township of Berkeley; and

WHEREAS, the Township of Berkeley wishes to donate to the County of Ocean Block 837.01, Lots 1.01, 1.02 & 1.06; and

WHEREAS, the County of Ocean agrees to accept Block 837.01, Lots 1.01, 1.02 & 1.06 and N.J.S.A. 40A:12-13 authorizes a municipality to accept property by the adoption of an ordinance authorizing the donation of same.

NOW, THEREFORE, BE IT ORDAINED by the governing body of the Township of Berkeley, County of Ocean, State of New Jersey as follows:

SECTION 1. That the governing body does hereby authorize the donation of Block 837.01, Lots 1.01, 1.02 & 1.06 to the County of Ocean. This property is being donated by the Township of Berkeley pursuant to N.J.S.A. 40A:12-13 to the County of Ocean.

SECTION 2. That the Mayor and Municipal Clerk are hereby authorized to execute any and all documents necessary for the donation of the subject property to the County of Ocean.

SECTION 3. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 4. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 5. This ordinance shall take effect after second reading and publication as required by law.
