**AN ORDINANCE OF THE TOWNSHIP OF BERKELEY, COUNTY OF OCEAN,
STATE OF NEW JERSEY, AUTHORIZING THE VACATION OF A PORTION
OF CUMBERLAND AVENUE BETWEEN HAYES AVENUE AND
COOLIDGE ABUTTING BLOCK 480 LOTS 17 & 19 AND 18 & 20.
BLOCK 479 LOTS 1& 2, 3 & 4**

November 20, 2023

WHEREAS, there exists a right-of-way on Cumberland Avenue (Between Hayes and Coolidge Avenues), **Block 480 Lots 17 & 19 and 18 & 20. Block 479 Lots 1& 2, 3 & 4**, on the Berkeley Township Tax Map, County of Ocean, State of New Jersey; and

WHEREAS, the Township Engineer has reviewed the request to vacate portions of Farrelly Avenue (Between Hayes and Coolidge Avenues), described in Schedule A, provided by the property owner of adjacent property owner, **Eileen Fisher**, and approves of same; and

WHEREAS, *N.J.S.A. 40A:12-13(b)(4)* authorizes the Berkeley Township Council to extinguish and vacate said portions of the street provided that said action is authorized by Ordinance.

NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of Berkeley, County of Ocean, State of New Jersey, as follows:

SECTION 1. There is hereby vacated all of the right, title, and interest of the public for all public usages and purposes in and to those portions of Cumberland Avenue (Between Hayes and Coolidge Avenues) abutting **Block 480 Lots 17 & 19 and 18 & 20. Block 479 Lots 1& 2, 3 & 4**, as is set forth on Schedule A, attached hereto and made a part hereof. However, the Township does hereby expressly reserve and except from the vacation all rights and privileges now possessed by public utilities, as defined in R.S. 48:2-13, and by any cable television company, as defined in the "Cable Television Act," P.L. 1972, c. 186, (C. 48:5A-1, *et seq.*), to maintain, repair and replace their existing facilities in, adjacent to, over or under the street, highway, lane, alley, square, place or park, or any part thereof, being vacated by the provisions of this ordinance.

SECTION 2. At least one (1) week prior to the time fixed for further consideration for final passage of this ordinance, a copy hereof, together with a notice stating the introduction of the ordinance on first reading and the time and place when and where the ordinance will be considered for final passage, shall be mailed to every person whose lands may be affected by the adoption of the ordinance.

1. Along the Westerly R.O.W. of Hayes Avenue South 00°00'00" West, 25.00 Feet to a point in the existing Southerly R.O.W. Line of Cumberland Avenue; thence
2. Along said R.O.W. Line, North 90°00'00" West, 300.00 Feet to a point in the Easterly R.O.W. Line of Coolidge Avenue; thence
3. Along said R.O.W. Line, North 00°00'00" East, 50.00 Feet to a point in the existing Northerly R.O.W. Line of Cumberland Avenue; thence
4. Along said R.O.W. Line, South 90°00'00" East, 300.00 Feet to a point in the Westerly R.O.W. Line of Hayes Avenue; thence
5. Along said R.O.W. Line, South 00°00'00" West, 25.00 Feet to the point and place of beginning.





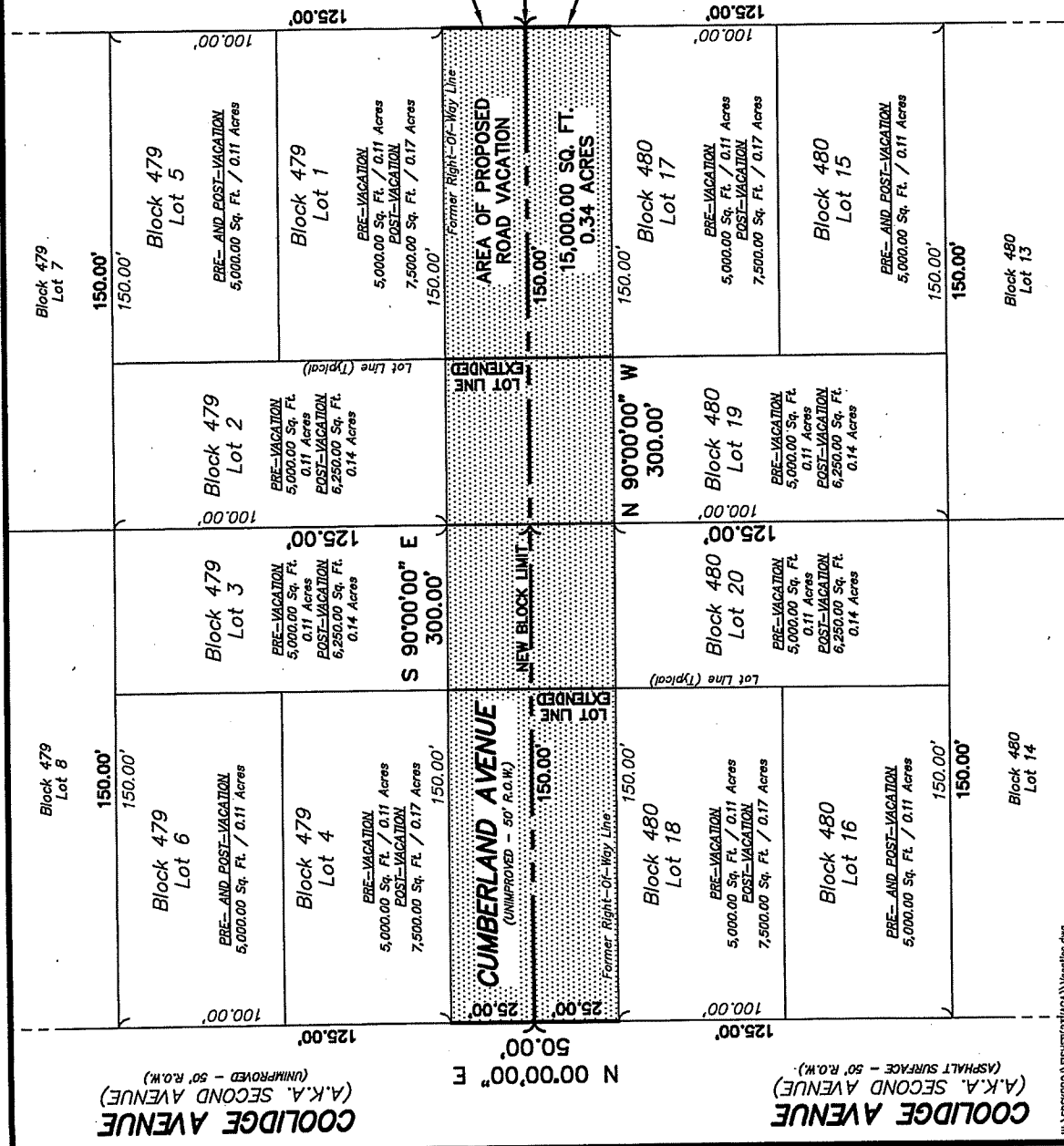

Our office has received the Application for Street Vacation for the above referenced Blocks and Lots. We have reviewed this application and offer the following:

- The Applicant has provided the attached submittals on the Application for Street Vacation form. The Applicant is proposing to vacate a 300 ft X 50 ft street vacation of a portion of Cumberland Avenue located between Hayes Avenue and Coolidge Avenue fronting Block 480, Lots 17 & 19, Block 480, Lots 18 & 20, Block 479, Lots 3 & 4 and Block 479, Lots 1 & 2. The Applicant known as Stephen and Eileen Fischer wishes to vacate this portion of Cumberland Avenue for personal use. The Street Vacation is shown on the attached tax map highlighted in yellow.
- The proposed vacation will not result in changes to the existing traffic patterns in this area.
- There have been no objectionable public comments.

In accordance with Chapter 17-2.2, our office recommends that the Township Council allows the 300 ft X 50 ft Street Vacation of a portion of Cumberland Avenue located between Hayes Avenue and Coolidge Avenue fronting Block 480, Lots 17 & 19, Block 480, Lots 18 & 20, Block 479, Lots 3 & 4 and Block 479, Lots 1 & 2. Should the Council issue a favorable determination, the Applicant will be required to provide the Township Clerk with all items required in Chapter 17-2.44.
