

ORDINANCE NO. 2023-26-OA

AN ORDINANCE OF THE TOWNSHIP OF BERKELEY, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING THE TOWNSHIP CODE, SO AS TO AMEND CHAPTER VII, ENTITLED "TRAFFIC" §7-14, ENTITLED "PARKING PROHIBITED DURING CERTAIN HOURS ON CERTAIN STREETS" (BOWSPRIT DRIVE)

June 19, 2023

BE IT ORDAINED by the Mayor and Township Council of the Township of Berkeley, County of Ocean, and State of New Jersey, as follows:

SECTION 1. Chapter VII of the Township Code of the Township of Berkeley, entitled "Traffic," is hereby amended so as to amend §7-14, entitled "Parking Prohibited During Certain Hours on Certain Streets," to include the roadway listed below which shall read as follows:

§7-14 PARKING PROHIBITED DURING CERTAIN HOURS ON CERTAIN STREETS.

No person shall park a vehicle between the hours specified any day (except Sundays and public holidays), except where other parking regulations have been provided for.

SECTION 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 3. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 4. This ordinance shall take effect after second reading and publication as required

by law.
