

ORDINANCE NO. 2022-20-OAB

AN ORDINANCE OF THE TOWNSHIP OF BERKELEY, COUNTY OF OCEAN, STATE OF NEW JERSEY AUTHORIZING THE DONATION OF BLOCK 38, LOT 134 AND BLOCK 46, LOT 110 TO HABITAT FOR HUMANITY IN ACCORDANCE WITH N.J.S.A. 40A:12-21

WHEREAS, the Township of Berkeley owns property designated as Block 38, Lot 134 and Block 46, Lot 110 in the Township; and

WHEREAS, Habitat for Humanity is a non profit housing organization, which provides housing to families in need; and

WHEREAS, Habitat for Humanity is looking to expand its efforts in the Manitou Park section of Berkeley Township; and

WHEREAS, Block 38, Lot 134 and Block 46, Lot 110 are in the Manitou Park section of Berkeley Township and the Township wishes to donate said property to Habitat for Humanity in connection with its mission of providing affordable housing; and

WHEREAS, N.J.S.A. 40A:12-21 authorizes a municipality to donate property to a duly incorporated nonprofit organization for the purpose of building or rehabilitating property.

NOW, THEREFORE, BE IT ORDAINED by the governing body of the Township of Berkeley, County of Ocean, State of New Jersey as follows:

SECTION 1. That the governing body does hereby authorize the donation of Block 38, Lot 134 and Block 46, Lot 110 to Habitat for Humanity. This property is being donated by the Township of Berkeley pursuant to N.J.S.A. 40A:12-21 to Habitat for Humanity.

SECTION 2. That the Mayor and Municipal Clerk are hereby authorized to execute any and all documents necessary for the acquisition of the subject property from the Habitat for Humanity.


SECTION 3. That the Mayor and Municipal Clerk are hereby authorized to execute any and all documents necessary for the recording of a conservation easement on the subject property, once acquired, for the benefit of the State of New Jersey.

SECTION 4. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 5. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 6. This ordinance shall take effect after second reading and publication as required by law.
