

**ORDINANCE NO. 2022-19-OAB**

**AN ORDINANCE OF THE TOWNSHIP OF BERKELEY, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING THE TOWNSHIP CODE, SO AS TO AMEND CHAPTER VII, ENTITLED "TRAFFIC"**

May 23, 2022

**BE IT ORDAINED** by the Mayor and Township Council of the Township of Berkeley, County of Ocean, and State of New Jersey, as follows:

**SECTION 1.** Chapter VII of the Township Code of the Township of Berkeley, entitled "Traffic," is hereby amended so as to amend §7--30, entitled "Speed Limits," to include roadways listed below which shall read as follows:

**7-14 PARKING TIME LIMITED ON CERTAIN STREETS**

No person shall park a vehicle for longer than time limit between the hours specified on any day (except Sundays and public holidays) upon any of the streets or parts of streets described.

Allen Road	Both	Dusk to Dawn	From Steerage Way East to Barnegat Bay
Amherst Beach	Both	Dusk to Dawn	Entire Parking Lot
Central Parkway	Both	7AM – 4PM	Between Marlin Drive and Eastern Exit of Clara B. Worth School
Main Street	Both	Dusk to Dawn	From South Bayview Avenue to the Water

**7-18 ONE-WAY STREETS**

[Ord. No. 04-30-OAB § 7-18; Ord. No. 2013-15-OAB; Ord. No. 2014-26-OAB; Ord. 2016-19-OAB]

The following described streets or parts of streets are hereby designated as One-Way Streets in the direction indicated. Parking on these streets will be permitted on the sides indicated below.

Butler Boulevard Ramp SE	East	Southeast ramp connecting Bayview Ave	No parking permitted on the ramp

**SECTION 3.** If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

**SECTION 4.** This ordinance shall take effect after second reading and publication as required by law.
