

ORDINANCE NO. 2022-17-OAB

**AN ORDINANCE OF THE TOWNSHIP OF BERKELEY, COUNTY OF
OCEAN, STATE OF NEW JERSEY, AMENDING THE TOWNSHIP CODE, SO
AS TO AMEND CHAPTER VII, ENTITLED "TRAFFIC"**

April 26, 2022

BE IT ORDAINED by the Mayor and Township Council of the Township of Berkeley, County of Ocean, and State of New Jersey, as follows:

SECTION 1. Chapter VII of the Township Code of the Township of Berkeley, entitled "Traffic," is hereby amended so as to amend §7--30, entitled "Speed Limits," to include roadways listed below which shall read as follows:

§7-30 SPEED LIMITS

Speed limits shall be established as follows. Regulatory and warning signs, conforming to the current Manual on Uniform Traffic Control Devices for Streets and Highways, shall be erected and maintained to effect the designated speed limit(s), as required by the Commissioner of the Department of Transportation of the State of New Jersey and as specified and authorized in writing from the Bureau of Traffic Engineering of the Department of Transportation.

Zone 1	35	From Ocean Gate Borough Line to Bowsprit Drive
Zone 2	30	From Bowsprit to Allen Road
Zone 3	35	From Allen Road to Bay Boulevard
Zone 4	35	From Bay Boulevard to Brennan Concourse
Chelsea Avenue		
Zone 1	35	From Pine Beach Borough Line to Santo Avenue
Zone 2	30	From Santo Ave to Ocean Gate Borough Line


SECTION 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 3. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 4. This ordinance shall take effect after second reading and publication as required by law.
