

ORDINANCE NO. 2021 -33-OA **3**

AN ORDINANCE OF THE TOWNSHIP OF BERKELEY, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING THE TOWNSHIP CODE, SO AS TO AMEND CHAPTER II, ENTITLED "ADMINISTRATION" (ADD DEPUTY TAX ASSESSOR)

August 3, 2021

BE IT ORDAINED by the Mayor and Township Council of the Township of Berkeley, County of Ocean, and State of New Jersey, as follows:

SECTION 1. Chapter II of the Township Code of the Township of Berkeley, entitled "Administration," is hereby amended so as to create §2-9.3, entitled "Deputy Tax Assessor," which shall now read in its entirety as follows:


§2-52.2 Deputy Tax Assessor

- A. There is hereby created the position of Deputy Tax Assessor for the Township of Berkeley who shall be appointed and serve in accordance with State Statutes. The Deputy Tax Assessor shall possess a Tax Assessor's certification in accordance with Title 54 of the New Jersey Statutes.
- B. The duties of the Deputy Tax Assessor are to assist the Tax Assessor of the Township in assessing the real properties in the Township of Berkeley in accordance with the appropriate State Statutes and regulations in regard thereto. The Deputy Tax Assessor shall do all work as is required of him by the Township Tax Assessor in regard to the assessing of real properties and all various other work as is required from time to time by the Tax Assessor.
- C. The Salary Range for this position will be between \$85,000.00 to \$110,000.00

SECTION 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 3. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 4. This ordinance shall take effect after second reading and publication as required by law.
