

ORDINANCE NO. 2021-24-OAB

AN ORDINANCE OF THE TOWNSHIP OF BERKELEY, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING THE TOWNSHIP CODE, SO AS TO AMEND SECTION 7-20, ENTITLED "STOP INTERSECTIONS"

June 28, 2021

BE IT ORDAINED by the Mayor and Township Council of the Township of Berkeley, County of Ocean, and State of New Jersey, as follows:

SECTION 1. Chapter VII of the Township Code of the Township of Berkeley, entitled "Traffic," is hereby amended so as to amend §7-20, entitled "Stop Intersection," to include the intersections of Lakeside Boulevard and Hayden Street, Whitmore Drive and Cortlandt Drive, and Zeeland Drive and Cortlandt Drive, which shall now be as follows:

§7-20 Stop Intersections

Pursuant to the provisions of N.J.S.A. 39:4-140, the intersections described are hereby designated as Stop Intersections. Stop signs shall be installed as provided therein.

Intersection	Stop Sign(s) on

Lakeside Boulevard and Hayden Street	Hayden Street
Whitmore Drive and Cortlandt Drive	Cortlandt Drive
Zeeland Drive and Cortlandt Drive	Cortlandt Drive

SECTION 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 3. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 4. This ordinance shall take effect after second reading and publication as required by law.
