

ORDINANCE NO.25-27-OA B

AN ORDINANCE OF THE TOWNSHIP OF BERKELEY, COUNTY OF OCEAN, STATE OF NEW JERSEY AUTHORIZING THE DONATION OF REAL ESTATE CONSISTING OF 74+ ACRES AND MORE FULLY DESCRIBED HERETO AS SCHEDULE A, TO THE COUNTY OF OCEAN, IN ACCORDANCE WITH N.J.S.A. 40A:12-13

May 19, 2025

WHEREAS, the Township of Berkeley owns real estate consisting of 74+ acres as listed on Schedule A hereto, which are located in the Township of Berkeley; and

WHEREAS, the Township of Berkeley wishes to donate to the County of Ocean all of the blocks and lots on Schedule A; and

WHEREAS, the County of Ocean agrees to accept the blocks, and lots as listed on Schedule A, and N.J.S.A. 40A:12-13 authorizes a municipality to donate property by the adoption of an ordinance authorizing the donation of same.

NOW, THEREFORE, BE IT ORDAINED by the governing body of the Township of Berkeley, County of Ocean, State of New Jersey, as follows:

SECTION 1. That the governing body does hereby authorize the donation of said blocks and lots as referenced on Schedule A to the County of Ocean. This property is being donated by the Township of Berkeley pursuant to N.J.S.A. 40A:12-13 to the County of Ocean.


SECTION 2. That the Mayor and Municipal Clerk are hereby authorized to execute any and all documents necessary for the donation of the subject property to the County of Ocean.

SECTION 3. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 4. If any section, subsection, sentence, clause, phrase of portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision, and such holding shall not affect the validity of the remaining portions hereof.


SECTION 5. This ordinance shall take effect after the second reading and publication as required by law.
