ORDINANCE OF THE TOWNSHIP OF BERKELEY, COUNTY OF OCEAN, STATE OF NEW JERSEY, TO PROVIDE FOR AND DETERMINE THE RATE OF COMPENSATION FOR CERTAIN OFFICIALS AND EMPLOYEE TITLES.

BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF BERKELEY, IN THE COUNTY OF OCEAN AND STATE OF NEW JERSEY AS FOLLOWS:





SECTION 3. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.


SECTION 4. This ordinance shall take effect after second reading and publication as required by law.
